# GUIDANCE NOTES FOR COMPLETING YOUR DEATH GRANT EXPRESSION OF WISH FORM

### WHAT IS A DEATH GRANT?

Under the LGPS Scheme Regulations a death grant may be payable when you die. Please visit the LGPS Members website which contains information on when a death grant may apply: https://www.lgpsmember.org/help-and-support/frequently-asked-questions

### WHO CAN RECEIVE A DEATH GRANT?

Any person(s) or organisation(s) may receive the death grant. If your beneficiaries are under the age of 18 (known as minors), the death grant will be held in trust until they come of age. We'll need to see documentary evidence of the Trust bank account to include the title, sort-code and account number (e.g. a letter from the bank on their own headed paper). For building society accounts we would also need the roll number. We will then pay the death grant directly into the Trust bank account.

### CAN I CHANGE THESE DETAILS?

You can update your death grant expression of wish anytime. You can do so by completing a new form, or by logging into our online portal, Pensions Online: <u>https://pensions.sutton.gov.uk/</u>. The most recent expression will revoke any previous expressions of wish.
